### PLEASE NOTE:

- By making recycling as convenient as possible, Harding hopes to boost its recycling rate and reach state goals. Our Recycling Center will maintain its expanded hours. You may continue to bring glass, plastic bottles, aluminum and steel mixed together (commingled) in one container.
- As of January 1, 2011, a new law will prohibit computers, monitors, laptops & televisions to be put out for trash collection. Proper disposal of these items is required. **ALL E-WASTE IS NOW ACCEPTED AT THE TWP RECYCLING CENTER.**
- Thank you for cooperating with our recycling efforts. Recycling is mandated by state, county and municipal laws. Most importantly, it benefits our community and environment, now and in the future. Fines can be issued to those who don't comply.

## WHAT TO DO WITH MANDATED ITEMS NOT ACCEPTED AT RECYCLING CENTER

1. Yard Waste – Compost leaves, twigs, etc. Small pieces decompose more quickly. Cut and leave grass clippings on lawn. For more information call (973-285-8394).
2. Motor Oil – Take to dealer or service station where items were purchased.
3. Small & Large Appliances – Working small appliances may be donated to New Vernon Volunteer Fire Department; large appliances to charities. *Call a local church or the Market Street Mission, (973-538-0427).* Non-working appliances are collected and recycled by the Township during **FALL CLEAN-UP STARTING MONDAY SEPTEMBER 30, 2019**
4. Oil-contaminated Soil  
Asphalt Roofing Shingles – Ask your contractor. Please be sure contractor submits Recycling Tonnage Report to the Municipal Recycling Coordinator.
5. Stumps, Logs & Natural  
Wood Waste – Ask contractor or contact the Morris County Municipal Utilities (MCMUA) at (973-285-8394).

## WHAT TO DO WITH NON-MANDATED RECYCLABLE ITEMS

1. Household Hazardous Waste – Includes: Pesticides, Herbicides, Oil-based Paints, Stains & Cleaners, Paint Thinners & Solvents, Automotive Fluids, Household, Pool & Darkroom Chemicals, Non-latex Driveway Sealer, small quantities of Asbestos (**100 lbs.**). Contact the MCMUA Household Hazardous Waste Hotline (973-829-8006) for information on material disposal.
2. Construction Materials  
(including Asphalt Paving) – Ask your contractor. Please be sure contractor submits Recycling Tonnage Report to the Municipal Recycling Coordinator.
3. Small Plastic Bags; Dry  
Cleaning Bags – Deposit clean bags in supermarket recycling bins; recycle at local cleaners.
4. Used Clothing & Bedding – Donate items in good condition.
5. Hard and Soft Cover  
Books in good condition\* – Donate to Harding Library. 1-973-267-BOOK
6. Used Bicycles\* – Donate. Bikes needing repair first can be donated to Pedals for Progress, (908-638-4811).
7. Housewares, Toys and  
and Furniture\* – Donate items in good condition.
