INQUIRIES-REQUESTS-COMPLAINTS:

In **January 2023** the Health Department received **3** complaint(s) for animal matters and possible renovations without permits; **2** inquiries from residents regarding, notary services, well water testing, and public health food information; and **4** requests for septic information from realtors, residents, prospective buyers, and engineers/contractors/septic inspectors.

Year-to-date 2023, the Health Department responded to 9 combined complaints/inquiries/requests; as follows:

ANIMAL CONTROL:

Dog Licenses

During the month of **JANUARY 2023**, the Health Department issued 278 dog licenses during the month of January 2023 with three being service dogs. The fee to the State is \$399.00.

For **JANUARY 2022** a total of 265 dog licenses were issued during the month of January 2022 with \$403.80 being issued to the State.

Year-to-date 2023, a total of 278 dogs have been licensed with three being service dogs.

CORRESPONDENCE RECEIVED

Animal Control Solutions, Block 35, Lot 21.10, Moreno, 19 Country Drive. Harding PD was notified of a bat in the residence and contacted Animal Control Solutions. ACS contacted the Health Department looking for the name, license number, and rabies expiration date of the dog. The dog was unlicensed and an application for 2023 was mailed to the owner.

Ever-Green Inspection Services, Block 23, Lot 7, Pratt, 24 Silver Brook Road, On Site Wastewater System. System was inspected on January 2, 2023, and was found to be in Unsatisfactory Condition. The conveyance line from the treatment tank to the absorption area is deteriorating with a partial obstruction, the d-box is collapsing, the laterals that exit the d-box were obstructed and causing

flowback and the absorption area was fully saturated.

- Ever-Green Inspection Services, Block 48, Lot 7.03, On Site Wastewater Treatment System A (garage). System was inspected on January 11, 2023, and found to be in Unsatisfactory Condition. The liquid level in treatment tank was elevated, a large volume of floating solids was observed, and the inlet and outlet baffles could not be observed due to the elevated liquid level. A camera was run through the conveyance line and an obstruction was encountered approximately five feet into the line.
- Ever-Green Inspection Services, Block 48, Lot 7.03, On Site Wastewater Treatment System B (barn). System was inspected on January 11, 2023, and found to be in Unsatisfactory Condition. The treatment tank main access lid frame was unsecured from the riser. The inlet and outlet access port are below grade preventing ease of access.
- Ever-Green Inspection Services, Block 48, Lot 7.03, On Site Wastewater Treatment System A (garage). Inspection is for the system near the garage and was found be in Unsatisfactory Condition. The absorption area was probed and found to be fully saturated.
