ANIMAL CONTROL:

Dog Licenses

During the month of **OCTOBER 2023**, the Health Department issued 1 dog license during the month of October 2023. The fee to the State is \$1.20.

For **OCTOBER 2022** a total of 2 dog licenses were issued during the month of October 2022, with one being a replacement tag and one being for a service dog. A total of \$5.40 was issued to the State.

Year-to-date 2023, a total of 418 dogs have been licensed with five being service dogs.

The treatment tank has high floating solids, elevated liquid level in conveyance line with liquids backing up towards the treatment tank, and the distribution box is deteriorated with elevated liquid level backing up into the conveyance line.
- Ever Green Inspection Services, Block 48, Lot 10, Grande, 72 Youngs Road, Septic System was inspected on October 12 and 13, 2023. The system Requires Addition Investigation, and it was requested that the Health Department be contacted to determine if the tanks were leak tested.
