

**HARDING TOWNSHIP  
ORDINANCE #01-2019**

**AN ORDINANCE OF THE TOWNSHIP OF HARDING AMENDING CHAPTER 171 OF THE TOWNSHIP  
CODE ENTITLED "FEES" AND SPECIFICALLY CHAPTER 171-1 ENTITLED "PURPOSE; FEE  
SCHEDULE ESTABLISHED"**

**WHEREAS**, the Township of Harding has established a certain fee schedule for various permits, licenses and activities and which is set forth in Chapter 171, Articles III (Construction Code), Article IV (Land Use and Development), Article V (Miscellaneous) and Article VI (Public Records and Documents); and

**WHEREAS**, the Township Committee of the Township of Harding finds that it would more efficient and less costly to allow the Township to adjust these fees, when appropriate, by way of resolution rather than by way of an amending ordinance.

**NOW THEREFORE BE IT ORDAINED** by the Township Committee of the Township of Harding, in the County of Morris, State of New Jersey, that Chapter 171 of the Township Code entitled "Fees" be and is hereby amended as follows [added portions are **bolded** and underlined; deleted portions have strikethrough]:

**SECTION 1. § 171-1 Purpose; fee schedule established.**

The following schedule of fees is hereby established with respect to licenses, permits and activities required or regulated under the provisions of various chapters of the Code of the Township of Harding. **The adjustment of any fee set forth and required pursuant to Chapter 171, Articles III, IV, V and VI, may be done by resolution of the Township Committee at such times as the Township Committee deems it necessary and advisable to adjust such fees.** Applications for and the issuance of such licenses and permits shall be subject to the provisions of the specific chapter of the Code which is indicated for each type of license or permit. The business, activity or operation for which the license or permit is required shall be subject to all regulations set forth in the chapter to which reference is made.


**SECTION 2.** At least three copies of said full Ordinance are on file in the Office of the Municipal Clerk for public examination and acquisition. Copies are available for inspection or acquisition during regular weekday working hours and arrangements have been made for the publication of said proposed Ordinance in pamphlet or other similar form which will be available for purchase from the Township Clerk.


**SECTION 3.** This ordinance shall take effect upon final passage and publication according to law.

**SECTION 4.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 5.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.
