HARDING TOWNSHIP ORDINANCE #08-2021

AN ORDINANCE BY THE TOWNSHIP OF HARDING IN MORRIS COUNTY, NEW JERSEY ESTABLISHING A MIDBLOCK CROSSWALK ON SAND SPRING ROAD, TOWNSHIP OF HARDING, COUNTY OF MORRIS, STATE OF NEW JERSEY

WHEREAS, N.J.S.A. 39:4-8 permits a municipality to establish certain regulations in the interest of public safety and the expedition of traffic along roadways under the jurisdiction of the Township of Harding; and

WHEREAS, the Township Committee feels it would be appropriate to establish a midblock crosswalk along Sand Spring Road for those persons utilizing Bayne Park at the point designated herein.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Harding, in the County of Morris, State of New Jersey, as follows:

SECTION 1. ESTABLISHMENT OF MIDBLOCK CROSSWALK ON SAND SPRING ROAD

- 1. The purpose of this Ordinance is to establish a midblock crosswalk at certain areas that are open to the public or to which the public is invited as set forth below.
- 2. Pursuant to the provisions of N.J.S.A. 39:4-8 and N.J.S.A. 40:49-2, which confers upon Harding Township the right to establish certain regulations in the interest of public safety and the expedition of traffic on roadways under Harding Township's jurisdiction.
- 3. The location herein is designated as a Midblock Crosswalk:

Name of Street Location

Sand Spring Road

In the area across Sand Spring Road that is Township of Harding approximately 475 feet northwest of the centerline of County of Morris, Blue Mill Road, State of New Jersey

- 4. Crosswalk markings and regulatory and warning signs shall be erected and maintained to effect the above designated Midblock Crosswalk in accordance with the Manual on Uniform Traffic Control Devices and guidelines established by the New Jersey Department of Transportaion.
- **SECTION 2**. At least three copies of said full Ordinance are on file in the Office of the Municipal Clerk for public examination and acquisition. Copies are available for inspection or acquisition during regular weekday working hours and arrangements have been made for the publication of said proposed Ordinance in pamphlet or other similar form which will be available for purchase from the Township Clerk.

SECTION 3. This Ordinance shall take effect upon final passage and publication according to law.
