HOST UPDATES:

Masterplan

Mr. Weppler reported he went through all the HOST members recommendations from the November meeting and encorporated them in the draft copy of the recommendations by HOST to be sent to the Planning Board. HOST reviewed the draft document. The following items were discussed:

- * Rural Character of Harding
- * Streams -- Need to protect Harding's streams
- * Greenway/Silverbrook -- Discussion ensued regarding the greenways around Primrose. It was recommended to add a sentence in the draft regarding greenways.
- * Stream Corridor Protection
- * Farmland Preservation

All HOST members agreed with the draft recommendations prepared by L. Weppler. L. Weppler will include the items discussed this evening and send it for a final review among all HOST members.

Blue Bird Boxes

N. Platt reported he would personally fund and oversee the blue bird boxes. L. Weppler explained how the blue bird boxes came up. L. Weppler appeared before the Township Committee on December 9, 2019 to present HOST's five (5) management plans. The Township Committee asked to see the budget numbers for HOST. The

Margetts Woods

L. Weppler reported that there are pine trees that have fallen at Margetts Woods. A discussion ensued regarding having someone from forestry come and evaluate these pine trees.

Mrs. Shapr mentioned she reviewed the proposal prepared by Mr. Johnston on Margetts Field but the proposal did not report the timing of the haying of Margetts Field.
